- ➢ All FOOD VENDORS MUST BE LICENSED WITH SANTA BARBARA COUNTY ENVIRONMENTAL HEALTH AND LICENSE ATTACHED TO THIS APPLICATION.
- > Vendors are responsible to bringing their own 10X10 canopy.
- > Vendors are responsible for bringing their own weights and/or tie-downs in case of wind.
- > Set-up time is 9 a.m. to 10:00 a.m. You will be directed to your space the day of the event.
- > All Vendors are expected to staff their respective booths until closing.
- > All Vendors are responsible for for maintaining and cleaning up their designated area. This
